The Oxfordshire County Council Spelsbury Footpath No. 12 (part), Public Path Diversion and Definitive Map and Statement Modification Order 2021

The above Order was made on 19 April 2021. The effect of the Order will be to divert the entire width of Spelsbury Footpath No. 12 running from OS grid reference SP 3584 2196 (point A on the Order plan) in a generally north-easterly, easterly, thence northerly direction for a distance of approximately 93 metres to a point situated at SP 3586 2204 (point H on the Order plan) **to** a line running from OS grid reference SP 3584 2196 (point A on the Order plan) in a generally north-westerly direction for a distance of approximately 11 metres to SP 3583 2197 (point B on the plan), then in a generally north-north-easterly direction for distance of approximately 37 metres to SP 3585 2200 (point F on the plan), then in a generally north-north-easterly direction for a distance of approximately 30 metres to SP 3584 2203 (point G on the plan) and then in an east-north-easterly direction for a distance of approximately 19 metres to SP 3586 2204 (point H on the plan) where it re-joins the existing route of Spelsbury Footpath No. 12.
