# Oxfordshire's Bus Service Improvement Plan

Earlier this year, the Government published a new National Bus Strategy which sets out a framework for how bus services can recover from the Covid-19 pandemic, with a vision for future improvements to bus provision.

To meet this challenge, Oxfordshire County Council is collecting views of the public and local stakeholders to create a Bus Service Improvement Plan. This will involve developing bold plans for improving Oxfordshire's bus services and encouraging more people to use them.

Government has pledged £3 billion in funding across the country to help deliver these plans, and Oxfordshire is aiming to secure as much as it can of that funding.

We want to find out what Oxfordshire's Town and Parish Councils think would improve our bus services and what would make you your constituents use them more.

**Better information during your journey** (e.g. departure screens at bus stops, "the next stop is" screens in buses etc.)

**More reliable buses** (e.g. through measures such as bus priority at traffic lights, more bus lanes etc.)

**More frequent buses**

**More buses in the evening and at weekends**

**Simpler and better value fares**

**Accessibility improvements** (e.g. better wheelchair access, raised kerbs at bus stops)

**New routes** (e.g. to places that don't have buses, or direct links between places that don't currently have them— specific routes/places can be listed in next question response)

**Better quality** (e.g. cleaner bus shelters, more comfortable buses etc.)

**More environmentally friendly buses** (e.g. electric buses)
